# LIMITED 10-YEAR WARRANTY FOR LITELUME ${ }^{\text {™ }}$ LED Product and Driver 

This limited warranty is provided by the LITE LUME CORPORATION ("LITELUME"). This limited warranty may be transferred to subsequent purchasers of the Product, provided that such Product is resold in new condition and in its original packaging.

LITELUME warrants that the LED electronics and components, when delivered in new condition in its original packaging and installed properly will be free of defects in material and workmanship for a period of TEN (10) YEARS from the date of original purchase.

This warranty is limited to the repair and replacement of parts required to return the LED product to its proper functionality. The determination of whether the Product is defective shall be made by Seller in its sole discretion with consideration given to the overall performance of the Product. If LITELUME determines the Product is defective, LITELUME will elect, in its sole discretion, to repair the Product, replace the Product, or provide a credit for future purchases.

## WARRANTY ACTIVATION

This limited warranty is considered activated if LITELUME receives the warranty registration form completed in its entirety within (60) days after shipment of the LED Product. Upon receipt of the completed warranty registration LITELUME will send a confirmation of the warranty's activation and a unique identifier for use if a claim is needed to be placed in the future.

## WARRANTY CLAIMS

To make a warranty claim, you must notify LITELUME in writing within THIRTY (30) DAYS after your discovery of the defect, provide proof of purchase such as the invoice and comply with other LITELUME warranty requirements. Your warranty claim should be sent via email to rma@litelume.com. Upon receiving that notice, LITELUME will review the claim, and if found valid will issue an RMA number to the direct purchaser from LITELUME. Claim request must include the following to be considered valid.

- Direct purchaser's name, address, and key contact
- Original PO number, part number, quantity, and reason for filing the claim.

When returning product for an approved warranty claim the direct purchaser must include a written description of the reason for return along with the RMA number issued by LITELUME in the product or packing list. ## WARRANTY LIMITATIONS

This limited warranty does not apply to loss or damage to the Product caused by: negligence; abuse; misuse; mishandling; improper installation, storage or maintenance; damage due to fire or acts of God; vandalism; civil disturbances; power surges; improper power supply; electrical current fluctuations; corrosive environment installations; induced vibration; harmonic oscillation or resonance associated with movement of air currents around the Product; alteration; accident; failure to follow installation, operating, maintenance or environmental instructions prescribed by LITELUME or applicable electrical codes; or improper service of the Product performed by someone other than LITELUME or its authorized service provider. This limited warranty excludes field labor and service charges related to the repair or replacement of the Product. THIS LIMITED WARRANTY IS VOID IF THE PRODUCT IS NOT USED FOR THE PURPOSE FOR WHICH IT IS DESIGNED.

THE FOREGOING WARRANTY PROVISIONS ARE EXCLUSIVE AND ARE GIVEN AND ACCEPTED IN LIEU OF ANY AND ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION ANY WARRANTY AGAINST INFRINGEMENT AND ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
